THE JOURNEY

Our long journey began in 2016 as the Council was at a crossroads. At that time, the maintenance of our building was gaining more and more momentum, and the funds for maintaining it were dwindling fast. The decision was to sell the building and look for a smaller place into which to move was made, and all of our history was packed into boxes and put into storage. The funds received from the sale of our building in 2016 were invested and will be used to help purchase a new property.

Good Shepherd Catholic Church opened its arms to us and offered their location as a place where we could continue Council business while the Realty Corporation looked for a new home for us. The Council worked with Central Catholic School and we were able to maintain our monthly breakfasts. This also formed a bond with the Council and the school as we kicked off Coats for Kids, food drives, and supporting the school with playground equipment and library books.

Since 2016, the Realty Corporation has looked at various properties and sites on which to potentially build. This has proven to be a difficult and frustrating task as multiple properties were visited and frank discussions were held regarding them all. Most of the properties had insufficient parking or had potential environmental problems that would have been inherited by us if not resolved with the seller.

In 2022, the Realty Corporation located a property at 4071 South Keystone Avenue—the site of Chase Bank—that was for sale. The price for same had dropped from over \$400,000.00 to \$325,000.00 and the property will have 56 parking spaces. With the help of Weichert Realty agent Dan Moriarty, the Realty Corporation began negotiations to purchase the building. There were no environmental red flags and a contract to purchase was made contingent on a zoning variance that would allow us to rent the property for small events. The zoning variance was granted and we hope to close on the property by the end of August or mid-September. The Council will finally have a new home!

Although not quite there yet, we at least can see the light at the end of the tunnel now and are most grateful! What we need now is for any of our members with licensed trades to step up and volunteer their time, materials or at cost, and experience as we begin to remodel our new building. If you can assist with this in any way, please contact a board member.
