RESOLUTION #1

WHEREAS Honorary Life members receive a Lifetime membership card from Supreme that contains their final degree status and if that card indicates that they are a third-degree member, and

WHEREAS these members are no longer subject to any dues or per capita by either State or Supreme Councils, and

WHEREAS, Supreme Council has instituted in 2023 membership cards that no longer require signatures of the Grand Knight, Financial Secretary or Member, and

WHEREAS, to save the Subordinate Councils expense of providing membership cards to Honorary Life members who are no longer subject to any dues or per capita, (possible savings of \$10.00 per card) and

THEREFORE, BE IT RESOLVED, that at all Knights of Columbus functions that require a current membership card, the Honorary Life Card will now meet this requirement for admission. State and Supreme functions would still need to have third degree indicated.

RESOLUTION #2

WHEREAS, Knights of Columbus is a Connecticut non-stock corporation (Knights of Columbus), which received its corporate charter from the General Assembly of the State of Connecticut in 1882, the year of the founding; and

WHEREAS, subordinate councils or other branches and divisions of Knights of Columbus (collectively “Subordinate Units”), hold charters conferred upon them by Knights of Columbus or are otherwise approved by the Board of Directors of the Knights of Columbus; and

WHEREAS, independent corporations which are incorporated under state law (“Home Corporations”) often provide premises for Subordinate Units to hold council meetings and other functions; and

WHEREAS, the Supreme Council wishes to clarify the policy which helps Subordinate Units avoid problems with Home Corporations before they occur and which enables Subordinate Units to resolve disputes with Home Corporations without litigation or acrimony.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the Charter, Constitution and Laws of the Knights of Columbus, including but not limited to, Section 4 of the Charter of the Knights of Columbus and Section 2 of the Constitution of the Knights of Columbus, the Supreme Council is hereby adopting a policy that Subordinate Units using premises of Home Corporations for meetings and other functions must have a signed terms of use agreement.

Therefore, At its next business meeting on January 9th, 2023, at 7:00PM, Msgr. James M. Downey Council 3660 will hold a vote to adopt a written motion that authorizes its grand knight/deputy grand knight to enter a Terms of Use Agreement and Charitable Distribution Agreement with Downey Home Association. Your attendance at this meeting is strongly encouraged.
